What you had to say...

Do you winterize your motorcycle? And if you do, do you add a fuel stabilizer?

Yes on the fuel stabilizer. I use it on all my stuff. - Don Gabriel

I do not winterize my trike, I keep it parked in the shade so as its not to hot to get on. However I do keep it full of Hi test gasoline because of the dry air. And carry a cooler of beer and water. AHHHHH! Lovely beaches. It was near 80 deg's today.

Enjoy life. See you all this summer. - Louise and Barry

Yes, I winterize my Bike, not much chance of riding it this winter.

- 1. I go to nearest Gas Station from Home and Add Stabilizer and Top Off Tank. Full tank helps prevent corrosion.
- 2. Change Crankcase Lube Oil. No sense in letting all those particulates/corrosives set and work on engine all winter.
- 3. Place it on 2 ft x 8 ft sheet of plywood with piece of Indoor / Outdoor Carpet over the plywood. *No sense in letting tires sit on cold concrete all winter.*
- 4. My garage never gets down to Freezing Temps.
- 5. Plug In battery tender to maintain battery
- 6. Maybe once a month I back my bike up and then roll it back onto the plywood. Prevents tires from sitting on the same flat spot all winter.
- 7. Every so often I may also back it out of the garage and run it to get lubes hot and circulating. Get rid of condensation in exhaust system



A trip to remember....Fred Zikowitz

For those who do not know me, my name is Fred Zikowitz. I bought my first Harley (and still only Harley) in June of 2007, at the age of 52. Prior to this, I had a 500 Kawasaki for one year which I rode on a permit. I did not have a bike in all the years since I was 19 and that was a 160 Honda and I had it for only about six months...too long ago to count anyway.

Point being, motorcycle riding was very new to me at the time. I'm happy to say my FLSTN has 69.500 miles on it now:) This is an excerpt from my journal that I kept, so please forgive me for grammar or lack of journalism. Thank you for letting me share one of my bike experiences with you.

I did ride my bike home in the springtime for a ride to remember and I was fortunate enough to have to repeat the trip.

Bike Ride from Dunedin Florida to Key West

March 2, 2008

This morning I'm sitting at a pool side table at the Florida home of Bob & Julie White, neighbors from my hometown of Readfield, Maine. I'm here as it happens by a series of events and plans to chase after my desire to tour on my Harley.

Back in November I decided to ship my bike down to Florida to ride occasionally with my brother, Zeke who lives in Dunedin and owns a 2006 Fat Boy. Since I bought my Softtail Deluxe last June, it has given our relationship new-birth. We talk more often on the phone about motorcycles and planned visits for me to ride. The first two trips were great, with good weather and nice rides (although, Zeke and I have completely different riding philosophies; and for me, it is difficult sometimes).

This trip I'm going out alone, with Key West as my destination. Zeke was to ride with me as far as Cape Coral where we were to visit an old friend of his. Yesterday was a beautiful day and after talking to Joan on the phone, we departed and headed south. I experienced my first mishap traveling on Route 19. I felt my bike swerve a bit. At first I thought perhaps it was groves in the road, it turned out to be my rear tire being deflated by a nail. After a tow truck ride to St. Petersburg to a Harley Dealership and \$320.00 and four and a half hours later, I made my way South. Bob and Julie have been very welcoming to me, and I'm thankful.

Zeke called to see if I made it here last night. He has a soft spot every once in a while.

I realize I started this journal writing as if telling a story to someone else, I'll try now to write as if just writing my thoughts....

Sure wish I had a hot cup of coffee!

Feeling a little less apprehensive about the ride. The opportunity is here and now and this will be good for the upcoming ride home to Maine in the spring. Sure glad I had HOG road side assistance yesterday.

With regards to work and the slowdown in business... keep the faith, who is in control? God.

I'm glad I had my bike blessed and went to confession. I felt chains being released as the priest gave absolution in the name of Christ. I wish though he had more time, I'm a piece of work.

3/3/08

Made it to Florida City last night. As I rode in a couple of bikers from Cincinnati Ohio followed behind. We pulled over to introduce ourselves and they were headed for the Keys as well. After checking price and availability at the hotel where they were staying the night I decided to look for a less expensive room elsewhere. Found one but not much less. Last night at this hotel I met people from Canada, not far from Toronto. They were heading to the Keys as well on their bike. They were very nice and I tried my limited French as usual. I also met some guys from Michigan, also on bikes and heading to Key West. Had a nice conversation with them and was invited to ride to the Keys with them this morning.

After waking up this morning I turned to the weather channel and I hope and pray I can make it back to Zeke's OK. There is a lot of storm activity from the Gulf to my home in Maine.

12:00 Midnight:

I just got in from experiencing night life on Duval Street..... I'm not in Readfield anymore! Hung out with the people I met in Florida City, Gary, Amy & Chuck. They were very pleasant and respectful to me, although I'm in a different place in my mind than they are. I did really enjoy their company.

Earlier in the day I walked Duval Street and then went for a bike ride to find a beach to watch the sunset. I don't smoke but I decided to have a celebratory cigar just for making it this far on the bike. Tomorrow I'll head north to my brother Zeke's. I don't know if I'll make in one haul. It will be a long bike ride 420 miles!

3/5/08

Made it back to Zeke's place last night, rode straight through from Key West to Dunedin. I took a different route through the center of Florida. I went from Route 1 out of the Keys to route 997N to 27N to 70 West to 75 then 275 to Saint Petersburg and onto Dunedin. It was a very strange ride. RT. 27, a barren land, part of the Everglades I believe, unlike RT. 41 on my way down to the Keys which also was barren (more wild than barren) this had a different feel to it. It was the part I believe that was not in the National Park. You had a feeling of being nowhere... hard to describe. After riding at 65 MPH for what felt like an hour on a straight road with nothing but a few trucks or vans, white unmarked vans and no other traffic I thought I was in the Twilight Zone. I then spotted a sign that read "Road Closed 11:00/2:00.

I said to myself "Oh Shit" I went on a little farther and saw a State Trooper, I asked about the road and he said they have been blasting during the week but it was ok now. That road seamed to never end with nothingness everywhere. I stopped at Osaka's near John's Pass for sushi before heading to Zeke's place. It's a beautiful day today and I have completed laundry, bike washing, and job site update. I would like to go out for a ride to get Zeke a birthday card, etc. Called Joan before leaving, she was talking to her brother John so I'll call her back.
